

## District and Local Centres

June 2013

### Centre Definitions

- The Maidstone Town Centre is a primary regional town centre and embraces a wide range of activities and performs many different main functions. It is expected that the planning for the future of Maidstone Town Centre will be achieved successfully through the use of an area action plan, with masterplans or development briefs for particular sites.
- District centres will serve a wider catchment than a local centre and will typically cater for weekly resident needs. It will usually comprise groups of shops often containing at least one supermarket or superstore, and a range of non-retail services, such as banks, building societies and restaurants, as well as local public facilities such as a library.
- Local centres include a range of small shops of a local nature, serving a small catchment. Typically, local centres might include, amongst other shops, a small supermarket, a newsagent, a sub-post office and a pharmacy. Other facilities could include a hot-food takeaway and launderette. In rural areas, large villages may perform the role of a local centre.
- Small parades of shops of purely neighbourhood significance are not regarded as centres.
